1	Approval of Election Schedule by the Executive Committee .The Secretary General of the Chamber shall display Election Schedule on the Notice Board and Website of the DGKCCI and shall submit to the Regulator Trade Organizations within 2 days.	July 18, 2024 Thursday
2	Member firms desiring to change their representative shall intimate changes regarding name of representative to the Secretary General along with necessary proof of eligibility.	July 25, 2024 Thursday
3	The Secretary General shall display the provisional list of all members eligible to vote along with their national tax no., sales tax-registration number, if applicable, the name and national identity card number of their representative. The list shall be displayed at:- (a) Notice Board of the Head Office of the trade organization, and (b) Website of the trade organization (Chamber).	August 01, 2024 Thursday
4	The member who has any objection to the entries in the provisional list of voters shall send their objections in writing to the Secretary General.	August 05, 2024 Monday
5	The Secretary General shall intimate action on the objections or changes sent by members.	August 07, 2024 Wednesday
6	Any member aggrieved by the decision of the Secretary General may make a representation to the Election Commission.	August 12, 2024 Monday
7	The Commission will decide the representation.	August 13, 2024 Tuesday
8	Any person aggrieved, with the decision of the Election Commission, or in case the Commission fails to decide the representation within the stipulated period may appeal to Regulator and decision of the Regulator in this regard shall be final.	August 19, 2024 Monday
9	The Regulator will decide the appeal.	August 26, 2024 Monday
10	The final list of voters shall be displayed at the Notice Board and at Website of the Chamber and shall be submitted to the Regulator.	August 27, 2024 Tuesday
11	Any person who is eligible to contest the election for the vacant posts of the member Executive Committee shall send his nomination papers duly proposed, seconded by a duly registered voter of his class and signed by the candidate, to the Secretary General on the prescribed form. In the same manner women entrepreneurs desiring to contest the election for the reserved seat in the Executive Committee for women will submit nomination papers.	Sep. 03, 2024 Tuesday
12	Scrutiny of the nomination papers by Election Commission and by that very fact applies the nominees of the women seats.	Sep. 05, 2024 Thursday
13	The Secretary General shall provide a copy of final list of voters to each contesting candidate except the candidates of the women seats, as their electoral college is Executive Committee. Any nominee or his agent wishing to be present at the Polling Station will be free to do so, one day prior to the election.	Sep. 05, 2024 Thursday
14	The Secretary General shall circulate the list of nominees whose papers have been declared valid and the forms of withdrawal to the said nominees.	Sep. 05, 2024 Thursday



15	The objection if any, to the nomination of candidates can be filed to the Election Commission. This clause ipso facto applies to the nominee of the women seats. Provided that the candidates for a particular seat will file objections for the candidate of the same seat and for the same class.	Sep. 07, 2024 Saturday
16	The election commission will decide the objections filed. This clause ipso facto applies to the nominees of the women seats.	Sep. 09, 2024 Monday
17	Any candidate, aggrieved by the decision of the Election Commission, where the commission fails to decide within the stipulated time may file an appeal to Regulator and his decision in this regard shall be final. This clause ipso facto applies to the nominee of the women seats.	Sep. 13, 2024 Friday
18	The Regulator Trade Organizations shall decide the referred appeal. This clause ipso facto applies to the nominees of the women seats.	Sep. 19, 2024 Thursday
19	The Election Commission will issue final list of candidates.	Sep.20, 2024 Friday
20	The Secretary General will receive the withdrawal forms from the nominees completed by the nominees who want to withdraw as a candidate from the election. This clause ipso facto applies to the nominees of the women seats.	Sep. 23, 2024 Monday
21	The polling at the registered office of the Chamber, for Corporate Members from 10.00 A.M. to 04.00 P.M.	Sep. 24, 2024 Tuesday
22	Polling for the Associate Members at the registered office of the Chamber from 10.00 A.M. to 04.00 P.M.	Sep. 25, 2024 Wednesday
23	<u>Note:</u> Counting of votes shall take place immediately after the polling hours under the supervision of Polling Officer in the presence of Polling Agents of the candidates, if any, at the designated site. The Returning Officer shall declare the provisional results.	---
24	Any person elected by the General Body in voting, as member of Executive Committee, shall send his nomination for election as an Office Bearer duly proposed and seconded by an elected Executive Committee Member and signed by the candidate to the Election Commission on the prescribed form.	Sep. 27, 2024 Friday
25	Scrutiny of the nomination papers for the election of Office Bearers by the Commission and issuance of the final list of candidates.	Sep. 28, 2024 Saturday
26	Polling for the election of Office Bearers from 10.00 A.M. to 04.00 P.M.	Sep. 30, 2024 Monday
27	The announcement of election results shall be made at the Annual General Meeting of the Chamber called for this purpose.	Sep. 30, 2024 Monday

**Explanation:**

- (i) If any day on which an activity schedule to be performed under the election program falls on a holiday, such act shall be performed on the day next following the holiday (s).
- (ii) Polling time is 10:00 A.M. to 4:00 P.M. with one hour lunch and prayer break from 1:00 P.M. to 2:00 P.M.
- (iii) For purpose of this schedule "Day" means working hours of the Chamber on that day unless otherwise stated. Any activity in connection with the election schedule will be performed within official working hours (9:00 A.M. to 4:00 P.M. except Friday i.e. 9:00 A.M. to 1:00 P.M., Sunday is holiday.)
- (iv) If for any reason any candidate does not receive any of the communication of the Secretary General in connection with his election, the election proceedings shall not be invalidated on that score.
